2. Adopter agrees to provide this animal with vet care at Adopter's expense, both on a regular basis and if the animal becomes ill or injured. Adopter agrees to be responsible for all vet expenses relating to this animal.
3. Adopter agrees to keep this animal as a pet and companion; it is never to be used as a mouser or barn cat, or for experimentation or research.
4. Sterilization of the animal is required as a condition of adoption.
